## **Business review**

The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 April 2021 to 30 June 2021 amounted to 521,268 tonnes and 801,173 tonnes respectively representing an increase of approximately 2.1% and 7.7% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 April 2021 to 30 June 2021 amounted to 886,595 tonnes and 1,012,089 tonnes respectively representing an increase of approximately 8.8% and 6.3% respectively as compared with the same period last year.

Revenue from our manufacturing business amounted to approximately RMB515.4 million for the three months ended 30 June 2021 representing an increase of approximately 0.8% as compared with the same period last year.
