## **Business review**

The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 October 2021 to 31 December 2021 amounted to 419,977 tonnes and 685,212 tonnes respectively representing a decrease of approximately 25.5% and 13.5% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 October 2021 to 31 December 2021 amounted to 738,724 tonnes and 856,067 tonnes respectively representing an increase of approximately 1.9% and 5.7% respectively as compared with the same period last year.

Revenue from our manufacturing business amounted to approximately RMB653.1 million for the three months ended 31 December 2021 representing an increase of approximately 88.6% as compared with the same period last year.

Further details of the Group's performance will be disclosed in the annual results of the Group for the year ended 31 December 2021 which is expected to be announced in March 2022.
