Business review

The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 October 2019 to 31 December 2019 amounted to 493,233 tonnes and 703,542 tonnes respectively representing an increase of approximately 12.4% and 7.0% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 October 2019 to 31 December 2019 amounted to 690,072 tonnes and 749,360 tonnes respectively representing an increase of approximately 23.8% and 29.4% respectively as compared with the same period last year.

Revenue from our manufacturing business amounted to approximately RMB297.5 million for the three months ended 31 December 2019 representing an increase of approximately 33.3% as compared with the same period last year.
