# **Business review**

The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 April 2020 to 30 June 2020 amounted to 510,388 tonnes and 744,208 tonnes respectively representing an increase of approximately 12.2% and 7.3% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 April 2020 to 30 June 2020 amounted to 815,193 tonnes and 952,184 tonnes respectively representing an increase of approximately 16.1% and 14.2% respectively as compared with the same period last year.

Revenue from our manufacturing business amounted to approximately RMB511.4 million for the three months ended 30 June 2020 representing an increase of approximately 120.2% as compared with the same period last year.

The business of the Group recorded a satisfactory recovery during the period from 1 April 2020 to 30 June 2020 in terms of sales and processing volume as well as revenue. As a consequence, the unaudited operating statistics of the Group achieved a similar level for the six months ended 30 June 2020 as its corresponding period in last year.

Further details of the Group's performance will be disclosed in the interim results of the Group for the six months ended 30 June 2020 which are expected to be announced in August 2020. Shareholders and potential investors are advised to read the interim results announcement of the Company when it is published.
