The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 July 2014 to 30 September 2014 amounted to 353,355 tonnes and 545,232 tonnes respectively representing an increase of approximately 23.5% and 34.2% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 July 2014 to 30 September 2014 amounted to 127,885 tonnes and 109,466 tonnes respectively representing an increase of approximately 51.9% and 44.1% respectively as compared with the same period last year.

The above operating information is unaudited and is based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such information.
