The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 April 2014 to 30 June 2014 amounted to 306,274 tonnes and 481,253 tonnes respectively representing an increase of approximately 30.5% and 39.6% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 April 2014 to 30 June 2014 amounted to 103,199 tonnes and 96,837 tonnes respectively representing an increase of approximately 75.8% and 66.1% respectively as compared with the same period last year.

The above operating information is unaudited and is based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such information.
